If You Received a Text Message from BioCollections Worldwide, Inc. You May Be Entitled to a Payment from a Class Action Settlement

A settlement has been reached in a class action lawsuit alleging that BioCollections Worldwide, Inc. (“BioCollections”) sent text messages to wireless telephone numbers without prior express written consent of the recipients as defined by the Telephone Consumer Protection Act, 47 U.S.C. § 227. BioCollections denies the allegations and any wrongdoing. The Court has not decided who is right.

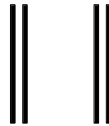
Who’s Included? The Settlement includes all persons who received a text message on their cell phone from BioCollections. Specifically, the class is defined as “**All individuals within the United States (i) who were sent a marketing text message during the relevant class period (ii) on his or her cellular telephone (iii) by or on behalf of Defendant.**” You received this email because records show that you may be a Settlement Class Member.

What Are the Settlement Terms? BioCollections has agreed to pay class members who submit a valid Claim Form and to pay for notice and administration costs of the Settlement, attorneys’ fees and expenses incurred by counsel for the Settlement Class, and a service award for the named Plaintiff. Each Settlement Class Member who submits a timely, valid, correct and verified Claim Form by the Claim Deadline in the manner required by this Agreement, making all the required affirmations and representations, shall be sent a Claim Settlement Check by the Administrator in the amount of \$35.00. Settlement Class Claimants will be sent their Claim Settlement Payments to the address they submitted on their Claim Form within 60-days following the Effective Date. One claim is allowed per Settlement Class Member per cellular telephone number that was sent a text message.

How Do I Submit a Claim Form? To get a payment, you must submit a Claim Form by the deadline stated below. You may submit the claim form attached to this postcard, download a Claim Form at the Settlement Website, www.BioCollectionsTCPAsettlement.com, or request a Claim Form by calling the Settlement Administrator at the toll-free number below. To be valid, a Claim Form must be completed fully and accurately, signed, and submitted timely. You may submit a Claim Form by U.S. Mail or file a Claim Form online. If you send in a Claim Form by U.S. Mail, it must be postmarked by **October 19, 2021**. Claim Forms submitted online must be submitted by **11:59 p.m. EST on October 19, 2021**.

Your Other Options. If you do not want to be legally bound by the Settlement, you must exclude yourself by **September 3, 2021**. If you do not exclude yourself, you will release any claims you may have, as more fully described in the Settlement Agreement, available at the Settlement Website. You may object to the Settlement by **September 3, 2021**. The Long Form Notice available on the Settlement Website explains how to exclude yourself or object. The Court will hold a Final Approval Hearing on **October 4, 2021** to consider whether to approve the Settlement, a request for attorneys’ fees of \$120,583.75, and a service award of \$2,000.00 to the named Plaintiff. You may appear at the hearing, either yourself or through an attorney you hire, but you don’t have to. For more information, call or visit the Settlement Website.

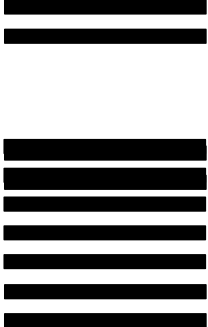
